## Health Agent Update

Date: October 17, 2022

1. **Multiple site Assessments**(ob/percs/etc) have been performed in the last two weeks. 461 Central Street, 721 Winter Street, multiple lots between Industrial Way and Central Street, 5 lots on Central Street,
2. **Repairs-** for approval-42 Washington Street.
3. **New Construction-** none submitted.
4. **Systems under construction** for new construction- 401 North Bedford Street, 781 Summer Street(tank) 485 Elm Street, 2 Susan Place.
5. **Food Inspections-** Follow-up Inspections at Johnny Mac's, and Fiesta and Deng's Garden. Routine inspections at Adria,( follow-up needed) Ridder's Event Space (Follow-up needed) and Golf Shop.
6. **Mosquitos-** No Eastern Equine Encephalitis (EEE) or West Nile Virus (WNV) has been detected in mosquitos trapped in our area to date. Have been trapped in neighboring towns of Whitman, Abington Hanson and Halifax.
7. **Housing** Ongoing concerns for 147 Thayer, 558 West Street, and 625 Bedford Street. Received notification from Public Health Council that Housing Regulations will be changing effective April 2023.
8. **Mileage-** Mileage increase due to several factors- I have been told to factor mileage from Town Offices out to the site and back to Town Offices. I tend to try and group my inspection but now I have been directed to go back to Town Offices. Also When doing new lot construction, in order to minimize time out of the office, we set up a lot, I go out and witness the perc and observation holes, and then go back to the office for 3-40 minutes to answer phone calls and then go back out to the site for the next lot when it is set up. This can happen for each lot that day. The Central St /Industrial Park area is accessed from 1.2 miles into Industrial Way(2.1 miles RT) to get off the site. The IRS has increased mileage to 62.5 cent/mile.(from 58.5).
