


- BOH approved Jeanmarie Joyce, Health Agent's vacation request for 11/21/22, 11/22/22 and 11/23/22.

Health Agent Update

Date: November 7, 2022

1. **Multiple site Assessments(ob/percs/etc)** have been performed in the last two weeks. Repairs for 130 Brenda Avenue, 238 West Pond Street, 627 Bridge Street, and 1257 Washington Street.
2. **Repairs-** for approval-560 Thatcher Street, 451 Central Street, 572 Bedford Street, 726 Winter Street and 178 Sherwood Street.
3. **New Construction-** Lot 2 Washington Street and 1961 Washington Street.
4. **Systems under construction** - 458 Elm Street, 353 Summer Street, 580 Plymouth Street, 112 Winter Street and 89 North Water Street.
5. **Food Inspections** - The Villa at Ridders, Adria, Johnny Mac's 2 (re-inspection needed), Standish Grill (voluntary closure (11/2/22, re-inspected, opened at 2 PM on 11/3/22.) The larger Food Establishments will be inspected, and any concerns addressed prior to the start of the holiday season.
6. **Mosquitos**- We have had a frost. Trapping Program closed for the year.
7. **Vaccine Clinic**- Heather has set an additional clinic for December 12 9-noon at the COA. As soon as she receives the sign-up link, I'll send out a notice (with the link) to Department Heads, Town Departments, Housing Authority and place an announcement on the website. Also will put together an announcement reminding the public of COVID procedures, availability of test kits and masks during the upcoming Holidays.
8. **Housing** Ongoing concerns for 147 Thayer, 558 West Street, and 441 Summer Street. Received notification from Public Health Council that Housing Regulations will be changing effective April 2023. Webinar Summary this week, in person trainings to begin in December.
9. **On Line Permits**- We will be sending out both email and in mail reminders and applications this year. Food Establishments, Milk Cream, Tobacco, Septic and Trash Haulers, Body Art Establishments and Practitioners all expire December 31, 2022. Installers also expire December 31 but we typically don't require them to renew until they have their first job in East Bridgewater. Both paper and on-line Permits will be available this year.
