The Board of Health (BOH) held a meeting at the Town of East Bridgewater Town Offices, 175 Central Street, East Bridgewater, MA in Conference Room First Floor. BOH Members present Robert Lyons (RL) Chair, Tom Duquette Jr. (TD) Vice Chair and Andrew Hudson (AH) Clerk. Also in attendance, Jeanmarie Joyce, (JJ), Health Agent and Sandra Abban (SA) Administrative Assistant to the Board of Health.

RL called the meeting to order at 5:00 pm and stated no appointments and one hearing at 5:15 pm.

Hearing:

The Chair, RL opened the hearing at 5:15 pm sighting The State Sanitary Code, Chapter II Minimum Standards of Fitness for Human Habitation 105 CMR 410.650.(D): Manuel Garcia (Tenant)- 91 Whitman Street, East Bridgewater.

Manuel Garcia (tenant) of 91 Whitman Street, East Bridgewater addressed his concern of no or inadequate heat. The chair, RL asked Mr. Garcia if the heating concern had been resolved, Mr. Garcia responded yes.

Paul Phillips (landlord) of 91 Whitman Street, East Bridgewater addressed the heating concern and how it was resolved.

Given that the reason for the hearing was no longer valid, the Board of Health did not issue a finding and the hearing was closed.
