OPEN FORUM

Jean Porter, resident, 268 Pine Street, Northville Cemetery Association member was present to express her concerns regarding the property at 218 Washington Street which is known as the "Northville School House Lot". Ms. Porter stated it has been a while since she has received information regarding obtaining an easement at the cemetery. Mr. Sheedy apologized, as there seemed to be some miscommunication. He provided Ms. Porter with a letter from Town

Council which was submitted to the Selectmen's office Friday, February 8, 2019 which provided all parties with an update. There was a discussion on the content of the letter and everyone was on the same page as to what the process of the Northville Cemetery acquiring the easement was.

Ms. Porter mentioned she would also like an update on Newcomb Tree and the apartments next to the Northville Cemetery. She stated, Newcomb has been placing more items on the location; oil barrels, office trailer, camper, trucks, old trailers, an expanding pile of woodchips etc. making it dangerous and unpleasant at funeral services. Ms. Porter stated that she's been to the Board of Health, Planning & Building and Conservation. Mr. Samia stated the Boards and Commissions are aware of this issue, however due to this being in litigation there isn't much that can be done at this point. The Selectmen's office will send a letter to Board of Health, Planning & Building and Conservation Commission requesting an update and report.
