6:30 pm Chairman Dowling called the meeting to order.

Chairman Dowling led the Pledge of Allegiance.

OPEN FORUM

APPOINTMENTS

Mr. Dowling stated that it's been three years since the Town put the Towns Insurance out to bid. The former Town Administrator did it three years ago with two firms. The Board felt it was time to look at the Insurance again to see if they could get any cost savings available for the Town. He stated that three bidders will present at tonight's meeting and a decision will be made in about a week.

Ken Fienberg, East Bridgewater Insurance Agency representative was present. Mr. Fienberg stated he uses Travelers insurance. He gave an overview on individual policies, how certain policies are put together and how they work with Departments. He also mentioned programs they offered as well as programs they would like to implement. Mr. Fienberg stated EBIA insures one Town, which is East Bridgewater.

Charlie Rourke, Estabrook Chamberlain Insurance Agency was present. He stated prior to EBIA, Estabrook Chamberlain was the Insurance carrier for the Town of EB for 18 years. Mr. Rourke stated they use Gladfelters Insurance, they write School Board Liability. He gave an overview on policies, payrolls, how certain policies work. Mr. Rorke stated that Estabrook Chamberlain insures 3 Towns, a couple school systems and one county.

David Labonte, Massachusetts Interlocal Insurance Agency representative was present. Mr. Labonte stated they based their quote on the information he received from the Town. He noted the differenced in the three bids. Mr. Labonte mentioned MIIA's property deductible is slightly lower, they include workers comp, property liability, and injured on duty. He mentioned credits the Town would qualify for, prepayment credit, and possible grants. He stated that East Bridgewater would be assigned a risk management representative, they have over 375 municipal entities, 6 reps.
