#### TOWN ADMINISTRATOR REPORT

Mr. Noble stated, the Police Chief, Paul O'Brien out of concern regarding the COVID- 19 pandemic has amended some procedures and implemented some temporary changes to the way officers respond to certain calls. This helps to practice the social distancing protocol.

Mr. Noble stated the Animal Control Officer will only be responding to high priority emergency calls during this time. Mr. Noble stated he received notification from State Representatives that the Governor signed the Bill that allows the Selectmen to postpone the Annual Town Election. A Board of Selectmen meeting will be posted to so. He stated the Governor's order makes us cut back the staffing at Town Hall The Departments will only be staffed by one person, or a limited number; rotating shifts. Essential services will still be provided to the Town.
