M/Margie, s/Dowling, a unanimous vote, for David Sheedy as Vice Chairman.

M/Sheedy, s/Margie, a unanimous vote, for William Dowling as Clerk.

Mr. Margie and Mr. Sheedy congratulated Mr. Dowling on his re-election.

Open Forum

Veteran's Agent, Robert Charles, mentioned the Veteran's Group that meets at the Community Center every second Wednesday at 10:00 am and would like to invite all veterans to attend the meeting. Mr. Charles also requested that everyone keep the military in their thoughts and prayers.

Appointed liaison for the Old Colony Planning Council and Joint Transportation Committee, Richard O'Flaherty gave an update on the Route 18 Project and stated this is one of the preferred projects for 2019. Mr. O'Flaherty informed the Selectmen that he will not be seeking re-appointment to the three committees he is part of, due to time constraints. The Selectmen thanked Mr. O'Flaherty for his years of service on these committees and will have a hard time finding a replacement to continue with everything he does.

Town Clerk, Dina Livingston, gave an update on the town election. Ms. Livingston stated that there were 1241 voters and listed the positions that were elected.

M/Margie, s/Sheedy, a unanimous vote, to approve the recommendation from the Council on Aging for the appointment of Stephanie Williams as an Associate Member of the Council on Aging effective April 10, 2017 through June 30, 2019.

Margie, s/Sheedy, a unanimous vote against, the approval to transfer the deed to the property which abuts the Northville Cemetery property, known as the original site of the Northville Schoolhouse, as recorded in Book #16848, Page 118, for the sum of one dollar, to the Northville Cemetery Corporation.

Mr. Samia explained the recommendation given by Town Counsel and the procurement laws.

M/Margie, s/Sheedy, a unanimous vote, to approve the request from the Fire Chief for the quarterly Ambulance Billing Abatements as of March 31, 2017 in the amount of \$24,610.80.

Mr. Samia explained that these are ambulance bills that are not paid and need to be taken off the receivables. The Chief has been doing it every quarter to avoid having a big abatement amount all at once.

M/Margie, s/Sheedy, a unanimous vote, to approve the request from the East Bridgewater Community Gardens for the use of the outside at the Sachem Rock Community Center for the Springtime Kickoff on April 22, 2017 from 12:00 pm-3:00 pm with a rain date of April 23, 2017.
