# Notice of Intent/General Stormwater Management Permit – Medeiros Court, 0 South St. - MA DEP# 148-1571

Discussion was had with Silva Engineering regarding the future maintenance of the proposed stormwater management system. It was agreed between the Commission and the Engineer that the Town of Bridgewater would be better suited to have the responsibility of the system as there is no access from East Bridgewater to the system and the water entering the system comes directly from a neighborhood proposed within Bridgewater. The owner is responsible for the system's maintenance until Bridgewater accepts the road at which point Bridgewater must be given access to the system for maintenance.
