- 2. Department Budget Presentations
  - a. Assessor Paula Wolfe
    - i. Salaries are contractual Paula will be taking longevity this year (skipped last year as contract was signed after the budget)
    - ii. Clerical contract just signed and she thinks came in at 2%
    - iii. Certification is now every 5 years
    - iv. People GIS many departments are using it and need to have a consolidated plan
    - v. May consider selling off some of the town land that can then be some new growth and contribute to the operating budget
  - b. Treasurer Melissa Morrissey
    - 1. Salaries Her salary is lower, and she is not taking the stipend
    - 2. Clerical already included the increase
    - 3. GIC Insurance estimates have gone down she gave us a new budget with the lower rates went down approx. \$96,000
    - 4. Debt service reviewed the sheet and what is dropping off
- 3. Request for Transfer from the Reserve Fund
  - a. To demolish the Carriage House located on Dube Dr.
    - i. Demolition included the removal of electric and water and septic
    - ii. The backup for the transfer did not match the total on the front sheet. We will need to get the corrected backup and then will consider
- 4. Next steps in budgeting process
  - a. We should consider meeting next week to continue reviewing the remaining budgets and talking about getting on the Board of Selectmen's schedule for 4/22
  - b. Jennifer Kitchenham has resigned from the Finance Committee. As a result, we will need to reassign her departments
