The purpose of the hearing will be to review a Form B Definitive Subdivision Application and Plan, submitted by PMP Consulting, Inc., on behalf of his client Hickory Hill Dev., also owner of record. The applicant is proposing a twenty (20) lot, single family, residential subdivision.
