Minutes: Approve minutes of December 16, 2019 M/Smith, S/Nolan with (4) four regular members (Gardner, Belcher, Smith and Nolan) in favor (0) none opposed.

Public Hearing: 7:00 p.m. Ridder Generations, Form B Definitive Plan – Bernie read the Public Hearing notice. Rebecca from Silva Engineering spoke for applicant. Roy spoke to Larry to change lot lines indicating roads meets & bound of individual lots. M/Gardner S/Smith (Gardner, Smith, Belcher & Nolan) with (4) four regular members in favor (0) none opposed to approve Form B, combine lots and abandon a portion of Anderson Street with changes as requested and discussed.
