Minutes: Approve minutes for October 17, 2022, December 5, 2022, **M/Reilly, S/O'Leary** with six (6) in favor, none (0) opposed.

Pending Matters: None at this time.

Other Matters: Layla Estates Road Bond was reduced from \$172,274.03 to \$60,000.00. **M/Reilly, S/Kenn** with six (6) in favor, none (0) opposed.

Discussion with Janelle Rotondi regarding details of upcoming Form A Application concerning land surrounding 64 Old Oak Street. Suggested that counsel for Ms. Rotondi arrange meeting with Building Inspector to further discuss.

35 Hereford Lane: Discussion regarding inclusion of Standard Condition No. 11 in Decision of Board. Cape Cod Berm should not have been required along new driveway access given width and overall design. Prior Decision should be amended. **M/Lawlor, S/Bates** with six (6) in favor, none (0) opposed.

60 Franklin Street: After discussion with counsel for Applicant, Board is willing to further modify Decision regarding used car location. Special Condition No. 1 to allow installation of new access door adjacent to existing garage doors. Existing doorway leading into drive-thru lane to be designated for emergency use only. **M/Reilly, S/Kenn** with six (6) in favor, none (0) opposed.
