Fire Chief, Tim Harhen was present to discuss his request to use up to \$325,000 of ARPA funds for an ambulance. Chief Harhen stated the price has decreased and that a 2020 ambulance is available now. His initial request at prior meeting was \$371,000 with a three-year waiting period. The Selectmen all agreed this will save time and money.

Ms. Julius made a motion to approve the request from Fire Chief, Timothy Harhen to use up to \$325,000 of ARPA funds for an Ambulance. Seconded by Mr. Spagone Jr. All were in favor. 3-0

There was a brief discussion on Saturday's blizzard. Chief Harhen stated his department had eight service calls, one storm related. He stated fifty-three residents were without power for about two hours on East Street. Police Chief, Paul O'brien stated service calls were handled with no problem as residents took caution and were not out and about. The Selectmen commended all that were involved, especially the Department of Public Works for their works and efforts.

There was a brief discussion on ARPA Committee. Mr. Seelig stated departments looking for funding should not serve on the committee to eliminate any potential conflict of interest. The Selectmen all agreed any non-resident or department head / department representative looking for ARPA funds best not serve.

Ms. Julius made a motion to end State of Emergency from the snowstorm as of 4:15 pm on January 31st. Seconded by Mr. Spagone Jr. All were in favor. 3-0
