OPEN FORUM

Paramedic, Patrick McKenna on behalf of Lieutenant, Philip Woolf was present to announce 13th year Toys for Tots program. EBFD will collect unwrapped new gifts and gift cards for newborn to 18 years of age and re distribute to East Bridgewater residents in need. APPOINTMENTS

Thomas O'Brien and Padraic Lydon of Plymouth County Retirement were present to discuss and give a brief update on Plymouth County Retirement Association. He briefly went over East Bridgewater Retirement Assessments. He stated the association will be fully funded in 2029. Mr. O'Brien stated the 52 member units of the Plymouth County Retirement Association will have paid off all of its liability and be back down to normal costs which will result in significant savings.

Senator, Michael Brady, Plymouth County Commissioners, Jared Valanzola, Sandra Wright, Gregory Hanley and Plymouth County Treasurer, Thomas O'Brien were present to give ARPA check from Plymouth County for playground equipment for \$49,960. The commissioners thanked all involved with application process.

Mr. Jeff Bandini, Project Manager for McMahon, a Bowman Company representing the Town of Bridgewater was present to discuss proposed heavy vehicle truck exclusion along East Street, Hayward and High Street in East Bridgewater and Bridgewater. He stated that the exclusion would extend into the Town of East Bridgewater via Hayward Street and East Street. Mr. Bandini stated as part of MA DOT regulations an alternate route needs to be established which two alternative routes are being examined. Mr. Seelig stated the Town cannot exclude trucks on Whitman and Plymouth Street.

ANNOUNCEMENTS / STAFF REPORTS

TOWN ADMINISTRATOR REPORT

Mr. Seelig stated appropriation for the Central School Building Project in terms of doing a feasibility study was approved at October Town Meeting. He stated the committee is holding monthly meetings and organizing subcommittees. The Town cannot start the process of hiring a project manager until the MSBA allows the Town to do so. The Town is scheduled to be on February 28, 2024 MSBA Board Meeting.

Mr. Seelig gave a brief update on North Bedford Street Sewer Project. He stated that the Town is awaiting various approvals from the Federal Government prior to funding.

Mr. Seelig stated the Town did receive funding from One Stop for Growth Grant for Downtown Sewer Study. He stated an engineering firm will confirm if the Town could extend a line from where it is right now on Beford Street, north to the Town Center. Possibly bring sewer and further develop properties in this area.

Mr. Seelig stated the Brownfield Application failed again. Brownfield program will not pay for the demolition of building. In another year or so, the Town can file a grant for site prep work. The Select Board will have to work with the Planning Board as to what will happen to parcel.

Mr. Seelig stated that the Town did not receive Open Space Plan Grant.

Mr. Seelig stated the Route 18 Corridor Study has been completed by OCPC. Meetings will be scheduled in 2024 regarding recommendations and incremental work with OCPC, MA DOT, and Town Officials.

Mr. Seelig stated the library would like to donate three portraits. Portraits of Judge Benjamin Winslow Harris, Samuel Angier, and Bass Odtis will be located at Town Hall.

Mr. Spagone Jr. made a motion to accept portraits. Seconded by Mr. Sheedy. All were in favor. 3-0

Mr. Seelig stated the Police Department was awarded two grants. Edward J. Bryne Justice Assistance Grant program, \$43,000 and Municipal Road Safety Grant, \$29,998. He stated East Bridgewater Cinema received a grant as part of an effort to save independent movie theaters.
