3. Disposal System Construction Permits

Local Upgrade — 98 Brenda Ave, East Bridgewater (1) Approval from section 310 CMR 15.212 of the State Sanitary Code which requires a minimum 4' vertical separation between the high ground water elevation and the bottom of the soil absorption system with a percolation rate greater than 2 minutes per inch. A variance allowing a reduction from 4' to 3' is requested. **(2)** Approval from section 310 CMR 15.211 of the State Sanitary Code which requires a minimum 20' setback from an in-ground pool to a SAS. A local upgrade approval allowing a reduction from 20' to a minimum of 17' is requested (liner provided). **(3)** Approval from section 310 CMR 15.227 of the State Sanitary Code which requires a minimum 12' vertical separation between the high ground water elevation and the lowest tank invert. A variance allowing a reduction from 12' to a minimum of 6' is requested.

Local Upgrade — 142 Plymouth St, East Bridgewater (1) Approval in accordance with DEP Policy #BRP/DWM/PeP-POO-1, allowing a percolation rate to be established via grain size distribution analysis is requested. **(2)** Approval from section 310 CMR 15.211 of the State Sanitary Code which requires a minimum 25' setback from a wetland to a septic tank. A local upgrade approval allowing a reduction from 25' to a minimum of 16' is requested. **(3)** Approval from section 310 CMR 15.211 of the State Sanitary Code which requires a minimum 50' setback from a wetland to a SAS. A local upgrade approval allowing a reduction from 50' to a minimum of 12' is requested (liner provided). **(4)** Approval from section 310 CMR 15.212 of the State Sanitary Code which requires a minimum 4' vertical separation between the high ground water elevation and the bottom of the soil absorption system with a percolation rate greater than 2 minutes per inch. A variance allowing a reduction from 4' to 2' is requested.

Local Upgrade – 502 Summer St, East Bridgewater (1) Approval from section 310 CMR 15.102 Deep Observation Hole Test a minimum of two deep observation hole tests shall be performed at every disposal area. Due to limited area in vicinity of proposed soil absorption system (water line, driveway, property line, existing plumbing one (1) hole is requested. **(2)** Approval from section 310 CMR 15.211 of the State Sanitary Code which requires a minimum 20' setback Due to slope in easterly direction and limited distance from property line to dwelling an impervious barrier as shown is to prevent effluent migration toward foundation el. (95.2 to 98.2) **(3)** Approval from section 310 CMR 15.212 of the State Sanitary Code which requires a minimum 4' (4.55 Plan) to eliminate mechanical pump system.
