4. Disposal System Construction Permits

Local Upgrade — 24-38 – 60 Crescent Street, East Bridgewater – Collins Civil Eng. Group, Inc. – Variance in accordance with **DEP Policy #BRP/DWM/PeP-POO-1**, allowing a percolation rate to be established via grain size distribution analysis is requested. A sieve analysis may be performed in accordance with department guidance if a percolation test cannot be performed.

Local Upgrade – 24-40 – 354 Bedford Street, East Bridgewater – Collins Civil Engineering Group, Inc. – **(1.)** Approval in accordance with DEP Policy #BRP/DWM/PeP-POO-1, allowing a percolation rate to be established via grain size distribution analysis is requested. **(2.)** Approval from section 310 CMR 15.211 of the State Sanitary Code which requires a minimum 50' setback from a wetland to a S.A.S. allowing a reduction from 50' to a minimum of 30' is requested. **(3.)** Approval from section 310 CMR 15.212 of the State Sanitary Code which requires a minimum 4' vertical separation between the high ground water elevation and the bottom of the soil absorption system with a percolation rate greater than 2 minutes per inch. A local upgrade approval allowing reduction from 4' to 3' is requested. **Variance Request – (1)** – A variance is requested to allow both a setback reduction to a wetland and a water table separation reduction to 3 feet concurrently (advanced treatment system provided).

Local Upgrade – 24-41 – 42 Browns Lane, East Bridgewater – Collins Civil Engineering Group, Inc. – **(1)** Approval from section 310 CMR 15.212 of the State Sanitary Code which requires a minimum 4' vertical separation between the high ground water elevation and the bottom of the soil absorption system with a percolation rate greater than 2 minutes per inch. A local upgrade approval allowing reduction from 4' to 3' is requested. **(2)** Approval in accordance with DEP Policy #BRP/DWM/PeP-POO-1, allowing a percolation rate to be established via grain size distribution analysis is requested. **(3)** Approval from section 310 CMR 15.2727 of the State Sanitary Code which requires a minimum 12' vertical separation between the high ground water elevation and the lowest tank invert. A local upgrade approval allowing a reduction from 12" to 3" (monolithic, seal coated tanks are provided).
