The **PLANNING BOARD** of the **Town of East Bridgewater** will hold a public hearing on **Monday, May 1, 2023 at 7:15 p.m.** in the Town Office Building, 175 Central St. large second floor conference room. The purpose of the hearing will be to review a Form B Definitive Subdivision Application and Plan, submitted by PMP Consulting, Inc., on behalf of his client Hickory Hill Dev., also owner of record. The applicant is proposing a twenty (20) lot, single family, residential subdivision.
