Local Upgrade Approval:

520 North Central Street, East Bridgewater

- Local Upgrade Approval from section 310 CMR 15.212 of the State Sanitary Code which requires a minimum 5' vertical separation between the high ground water elevation and the bottom of the soil absorption system with a percolation rate less than 2 minutes per inch. A local upgrade approval allowing reductions from 5' to 4' is requested.
