The Board of Appeals will hold a public hearing on **Wednesday, May 6, 2020 at 7:30 p.m.** in the Town Office Building, 175 Central St. second floor conference room, on the petition of **Francis and Nancy Angelo**, Owner/Applicant seeking a **VARIANCE** for relief from **SECTION 6.D.(1) LOCATION** under the Zoning By Law and for all petitions and such other relief as the Board may deem appropriate. The Petitioner seeks to allow construction of an accessory building within the side yard setback for the PROPERTY located at **686 Summer Street** (Assessor's Map 111, Block 20) and located in a Residence 1 (R-1) Zoning District.
