## **BOARD DISCUSSION**

Mr. Sheedy made a motion to not authorize any rentals at the Senior Community Center function hall until we get information from the governor that phase 4 will be implemented. Seconded by Mr. Spagone Jr. All were in favor, 3-0

Building Commissioner/Zoning Enforcement Officer, Patrick Franey was present to discuss the vacant property on 131 Hubbard Road. He suggested to demo property and went over the process. He stated the town cannot get ahold of property owner or the owner's heirs.

Treasurer/Collector, Melissa Morrisey was present and stated the land court is held up and cannot work on any cases. Ms. Morrisey went over process on finding the property owner.

Ms. Julius stated appointments and reappointments of constables will not take place until the State comes out with legislation or recommendations on how this will work.

Mr. Noble requested the Selectmen postpone any appointments / reappointments.

Mr. Spagone Jr. made a motion to discontinue appointments and reappointments for constables.
