- 1. Meeting called to order at 6:05PM
- 2. School Department Superintendent Legault & Business Manager John Shea
 - a. Replacement of Smartboards at Central & Mitchell Schools: XXXX, equipment is aging and needs replacement
 - b. Replacement of Desktops at Central & Mitchell Schools: \$10,788. Replacing machines that are running on Windows 7.
 - c. Replacement of Chromebooks for one grade level at Mitchell School: \$35,520. This request will occur as a regular request on a go forward basis to replace one grade at a time.
 - d. Replacement of Lighting System in Mitchell School Auditorium: \$53,257.00. This replaces original lighting that dates back to the early 1990's.
 - e. Replacement of Jr/Sr High School Lecture Hall Video Processor: \$10,695.00. For years the school has tried to buy parts to fix this as it breaks and they are not able to get parts. While this item doesn't meet the threshold for a Capital Expense, the committee was asked to make an exception.
 - f. Replacement of Networking Switches & UPS Devices at Central & Mitchell Schools: \$XXXXX. This project may be reduced by 50% of cost as the Town is applying for reimbursement. The town must first spend the money and then get the reimbursement.
 - g. Radio Replacement: \$4,605. To replace broken radios. *Does not meet capital threshold* rejected.
 - h. Replace floor rug in STEAM Lab at Mitchell School: \$25,000. Discussed and should be part of Facilities budget. Will not recommend to move forward.
