BOARD TO REORGANIZE

M/Spagone Jr., s/Julius, a unanimous vote, for David Sheedy as Chairman, Peter Spagone Jr. as Vice-Chairman and Carole Julius as Clerk effective 4/12/2021 until next April Election.

OPEN FORUM

Town Clerk, Susan Gillpatrick, gave an update on the town election. Ms. Gillpatrick stated there were 1,071 voters and congratulated all the candidates who won their seats. The Board of Selectmen commended town election candidates.

Chief Paul O'brien and Deputy Chief Michael Jenkins were present to update the Selectmen on their plans to add a Police K-9. Deputy Chief Jenkins stated all the surrounding communities have K-9s and is a great asset to the department. The Chief and Deputy Chief received a phone call from town resident Michael Payton who is very involved with a non-profit foundation, The Hometown Foundation, Inc. out of Connecticut. The foundation donates fully equipped Police K-9s to local and state departments across the country. He briefly went over the estimated cost of a K-9, stating the average cost is around \$25,000. He reiterated The Hometown Foundation, Inc. donates Police K-9 at no cost to the department. Once the foundation advised they have a K-9 available the Deputy Chief sent out a message to the department looking for a K-9 handler. He stated he received great feedback from the officers and will have a selection process. Deputy Chief Jenkins stated the department is receiving support from local businesses and residents to help donate. Mr. Sheedy wanted to know how long the handler training is. Deputy Chief Jenkins stated 16 weeks and briefly went over process and program.

Interim Town Administrator James Purcell stated he spoke with both chiefs regarding K-9 addition last week. He stated there are procedures the Town must follow when accepting donations and gifts.

BOARD DISCUSSIONS

Owners proposed a build out and is still interested in continuing the process to see if there are some things they can do as far as mixed use and potentially working with the town on the Waste Water Treatment Plant.
