**Susan Mulloy provided an update on COVID.** On May 29<sup>th</sup> ALL COVID restrictions will be lifted and the Face Covering Order will be replaced with an Advisory for unvaccinated individuals. (information to be posted on website and Facebook). Schools will still be required to follow DESE guidance regarding face coverings and social distancing. Cases continue to trend down.

A vaccination clinic is being offered at the High School this Thursday sponsored by our office and the FD for children 12-18 utilizing Pfizer vaccine. The school has sent out emails inviting families to register. A second dose clinic will be held 3 weeks later. We were able to obtain our vaccine through our collaborative with the BSU vaccination site.

**Discussion regarding office operations:** The Interim Town Administrator signed a MOU with Robert Buker of Buker and Sons to provide septic inspection and plan review services at “fee per service” pricing. A copy of the MOU is available in our office. Additionally, there is a meeting on Wednesday for all Departments to discuss the services of Environmental Partners.

**Bridge Street Landfill:** There was talk of a proposed “gun range” at the landfill, however, the Police Dept has made alternate arrangements with the City of Brockton. The proposed Burn Building at the landfill that was previously presented and approved by the BOH is on hold until we verify the exact location as it compares to the “site assignment”.

**The YMCA** has applied for a camp permit. Rob Casper will conduct a pool inspection prior to issuing the permit and will do an operation inspection once they are up and running.

**Community Coalition for Change** is having an event on the common on 6/13. It was on Agenda as it pertained to COVID restrictions, however, they will be lifted at time of event. All Food Vendors will be permitted.
