## **APPOINTMENTS**

Mr. Peter Furia and Ms. Theresa McNulty of the Recreation Commission were present to give an update. Mr. Furia announced "Summerfest" event on August 21, 2021 from 3:00 pm – 8:00 pm: Rain Date August 22 at the high school baseball fields and Town Hall. There was a brief discussion on event and what is involved. Mr. Furia gave a brief update on Temporary Part time Recreation Assistant, Jen Poole. There was a brief discussion on commission whereabouts and future plans. Mr. Spagone Jr. commended the commission for their works and efforts. Mr. Spagone Jr. discussed using the "American Recovery Act" funds to help support "Summerfest" event. He stated this event could possibly fall under recovery act guidelines and would like administration to look into this further.

Mrs. Melanie Dean was present for her contract signing. She gave a brief background of her training and previous job experience. The Selectmen looks forward in working with her.

Mr. Purcell commended all the departments heads and Mrs. Rebecca Johnson for their works and efforts. Mr. Sheedy stated Massachusetts State Representative, Michelle Dubois came in last week and asked the Town and the schools to put together a "wish list" for Federal funds.
