Housing Order Appeal / Christopher Tartaglione / 1357 Washington Street

Mr. Tartaglione requested a hearing to appeal the Housing Order issued by the Health Agent, Jeanmarie Joyce. Also present for this hearing is the property owner, Edward Johnson. Jeanmarie gave a brief update and let the Board know that most things had been addressed except the condition of the yard. She gave the tenant 20 days to remove the junk/debris in the yard and if it was not done within that time the property owner should have it cleaned up within 30 days. Mr. Tartaglione feels that Order has discrepancies regarding the amount of people living in the home and the bathroom, however, the Board has advised him that the discussion will be limited to the Order at hand which involved the area in the yard. Mr. Tartaglione would like the Board or the Agent to identify what specific items they want removed and what quantity of buckets, planters, pallets etc. can he have. Mr. Johnson states that although there is still a lot of junk out there, some progress has been made by the tenant to clean it up. After much discussion, the Board voted to have the Health Agent meet Mr. Tartaglione on site to specify what needs to be removed and an appointment was set. Additionally, an extension was given to allow the work to continue once the items had been identified. The final inspection was pushed out to July 11, 2022.
