BOH Members present Tom Duquette Jr. (TD) Vice Chair and Andrew Hudson (AH), Clerk. Also in attendance, Jeanmarie Joyce, (JJ), Health Agent and Sandra Abban (SA) Administrative Assistant. Absent, Robert Lyons (RL) Chair.

TD called the meeting to order at 5:00 PM and stated there are no hearings and no appointments.

Action Items:

Approval of Bills

AH made a motion to approve Professional Services Consultant – Kayla Smith, Invoice 36 West Union St Perc, Amount \$200.00; Professional Services Consultant. TD seconded the motion. So moved.

Disposal System Construction Permits

AH made a motion to approve as submitted **603 Crescent St, East Bridgewater - 310 CMR 15.405 (1)(h)** To reduce the 5' separation from S.A.S. to E.S.H.G.W. to 4' (4.15' provided) **310 CMR 15.405(1)(I)** To allow the use of a sieve analysis in place of a percolation test. TD seconded the motion. So moved.

AH made a motion to approve as submitted **4 Keene Lane- 30 CMR 15.405(1)(h)** to reduce the 4' separation from the SAS to ESHGW to 3'. From **310 CMR 15.405(1)(h)** to allow the use of a sieve analysis in leu of a percolation test. This is an undersized lot (10.682 sf) in Zone II (Aquifer Protection Area) and will be restricted to a 3 bedroom/7 rm dwelling due to the lot size, groundwater variance and no percolation test. TD seconded the motion. So moved.
