The Board of Health (BOH) held a meeting at the Town of East Bridgewater Town Offices, 175 Central Street, East Bridgewater, MA in Conference Room First Floor. BOH Members present Robert Lyons (RL) Chair, Tom Duquette Jr. (TD) Vice Chair and Andrew Hudson (AH) Clerk. Also in attendance, Jeanmarie Joyce, (JJ), Health Agent and Sandra Abban (SA) Administrative Assistant to the Board of Health.

RL called the meeting to order at 5:00 PM and stated there are no hearings and no appointments.

Action Items:

Approval of Bills

AH made a motion to approve - Crystal Rock, Invoice #1016063012123, Amount \$10.58, water; B&D, Invoice #36142, Date 10-24-23, Amount \$240.00, Medical Waste pickup; Happy Frog Inc, Invoice #20365, Date 11-14-2023, Amount \$75.00, BOH "Received" Ink Pad. TD seconded the motion. Motion passed unanimously.

Approval of Minutes

AH made a motion to approve October 16, 2023, minutes as submitted. RL abstained. TD seconded the motion. So voted.

RL made a motion to approve November 6, 2023, minutes as submitted. AH abstained. TD seconded the motion. So, voted.

Disposal System Construction Permits

Local Upgrade Approval - RL made a motion to accept as submitted **23 Cottage Street, East Bridgewater** – **1) LUA- From 310 CMR 212** to allow 3 feet to maximum groundwater instead of the required 4 feet. **2) DEP #BRP/DWM/PeP-POO-1** to allow a sieve analysis in lieu of a percolation test. **3) LUA- From 301 CMR 15.211** to allow a 15-foot setback from a foundation wall to the SAS instead of the required 20 feet (liner provided). AH seconded the motion. So, voted. Motion passed unanimously.

New Construction

RL made a motion to accept as submitted **18 Daisey Lane, East Bridgewater** and **112 Cedar Street, East Bridgewater** new construction. AH seconded the motion. Motion passed unanimously.
