January 9, 2023

Board of Health (BOH) held a meeting at the Town of East Bridgewater Town Offices, 175 Central Street, East Bridgewater, MA in Conference Room First Floor. BOH Members present – Lisa Lesogor (LL) Chair, and Tom Duquette Jr. (TD) Clerk. Also in attendance, Jeanmarie Joyce (JJ) Health Agent and Sandra Abban (SA) Administrative Assistant. Absent Robert Lyons (RL) Vice Chair.

Chair, LL called the meeting to Order at 5:05 PM.

Chair, LL stated that there were no hearings scheduled and no appointments scheduled.

Action Items:

Payment of Bills

LL made a motion to pay invoices Bridgewater Trophy, Invoice #21678, Amount \$131.90, Health Agent's Badge and Case, B&D Associates, Inc., Invoice #34235, Amount \$185.00, Medical Waste and Jeanmarie Joyce, MHO 2022 Annual Conference, Amount \$450.00. TD seconded the motion. So, voted.

Approval of Minutes – December 19, 2022

LL made a motion to approve the minutes from December19, 2022, as drafted. TD seconded the motion. So, voted.

Disposal System Construction Permits

LL made a motion to approve as submitted 530 Bridge Street Variance request: Allow the use of a sieve analysis to determine the L.T.A.R. instead of a percolation test. TD seconded the motion. So, voted.

LL made a motion to approve 2023 Food Establishment Renewals. TD seconded the motion. So, voted.

Body Art Practitioners

LL made a motion to approve 2023 Body Art Establishment renewal and Practitioner renewals. TD seconded the motion. So, voted.

Installer License

LL made a motion to approve 2023 Disposal Works Installer's Licenses. TD seconded the motion. So, voted.

Hauler Permit

LL made a motion to approve as listed (see attachment) Hauler Permits. TD seconded the motion. So, voted.

Housing 147 Thayer Steet

Tenants of 147 Thayer Street came in to speak with the Board. LL, Chair asked tenants to submit a public hearing request by the end of the week to be placed on the Board's meeting agenda for January 23, 2023.

Betterment Loan Application

Board reviewed and discussed the revised Local Septic Management Program WPAT Loan Application and WPAT Loan Program for Homeowners Questions and Answers.

LL made a motion to approve the revised application and homeowner's questions and answers as drafted, i.e., - the loan is available to residential owner-occupied and multifamily owner occupied (five units, seven bedrooms maximum) and a maximum loan amount of \$75,000 with any additional funding to be brought in front of the Board. TD seconded the motion. So, voted.
