Also in attendance, Robert Buker, HPHEG Shared Services Coordinator Town of Halifax and Sandra Abban (SA) Administrative Assistant. Absent was Tom Duquette Jr. (TD) Vice Chair and Jeanmarie Joyce, (JJ), Health Agent.

Chair, RL called the meeting to Order at 5:05 PM and stated there are no hearings or appointments scheduled.

Action Items:

Approval of Minutes

2023 LBOH Arbovirus Coordinator

Board discussed the Massachusetts Department of Public Health yearly appointments of a Primary and Back-up Arbovirus coordinator to receive notification about WNV and EEE virus positive specimens (mosquito, veterinary, or human) within the community.

RL agreed to be the primary contact with AH as the back-up.

Municipality Statement of Commitment and Inter-Municipal Agreement (IMA)

Bob Buker, HPHEG Consultant for the Town of East Bridgewater discussed with the board what the municipality statement of commitment is and what HPHEG is looking for regarding the IMA.

RL, stated the board will sign the Municipality Statement of Commitment tonight and forward to HPHEG. He also stated that the board will review the IMA and forward any questions or suggestions to HPHEG.

Board of Health Department Update – there were none.


Topics Not reasonably anticipated by the Chair – there were none.
